Purpose:

By this advice letter, California American Water requests authorization to revise its Private Fire Rate Schedule tariffs. The changes are:

- Add the following tariffs:
 - Create new Private Fire Hydrant sheets (1-4) to replace sheets (10-13).

- Delete the following tariffs:
 - Monterey Special Condition and Surcredit (Item 3 & 4), which are no longer effective.
 - San Diego Special Condition (Item 6) from sheet (9454-W), which is no longer effective.
 - Los Angeles Special Condition (Item 2) from sheet (9448-W), which is no longer effective.
 - Sacramento Special Condition (Item 1) from sheet (9450-W), which is no longer effective.
 - Private Fire sheet (8001-W) and Private Fire Hydrant sheets (10-13 and 8002-W), which are no longer effective.
- Modify the following tariffs:
 - Reinstate Special Condition (Item 1-3) from AL 1072-B which was mistakenly omitted in AL 1230-B.
 - Updated business fee and franchise fee on Private Fire Hydrant sheet to be consistent with sheet 4 (9231-W) Tariff sheet (9453-W) was inadvertently not updated with the approved and properly billed fees.
 - Updated Special Condition to Rio Plaza District surcharge on sheet 9 (9450-W), which was inadvertently not updated with the approved and properly billed rate.

The above changes do not impact authorized rates and all customers were billed correctly with respect to the modifications addressed above

Background:

In an effort to maintain accurate tariffs, California American Water will continuously review its tariffs to identify tariffs that need to be added, deleted and modified.

Request:

California American Water is requesting authorization to revise its Private Fire Rate Schedule Tariffs.

Tier Designation:

These tariffs are submitted pursuant to General Order No.96-B and this advice letter is designated as a Tier 1 filing.

Effective Date:

California American Water requests an effective date of April 15, 2020.

Notice

Per guidance from the California Public Utilities Commission's Water Division, during the COVID-19 pandemic advice letters will only be delivered electronically to the service list. Hardcopy advice letters will be mailed as soon as administrative staff are able to return to California American Water offices.

RESPONSE OR PROTEST¹

Anyone may submit a response or protest for this AL. When submitting a response or protest, **please include the utility name and advice letter number in the subject line.**

A **response** supports the filing and may contain information that proves useful to the Commission in evaluating the AL. A **protest** objects to the AL in whole or in part and must set forth the specific grounds on which it is based. These grounds² are:

1. The utility did not properly serve or give notice of the AL;
2. The relief requested in the AL would violate statute or Commission order, or is not authorized by statute or Commission order on which the utility relies;
3. The analysis, calculations, or data in the AL contain material error or omissions;
4. The relief requested in the AL is pending before the Commission in a formal proceeding; or
5. The relief requested in the AL requires consideration in a formal hearing, or is otherwise inappropriate for the AL process; or
6. The relief requested in the AL is unjust, unreasonable, or discriminatory, provided that such a protest may not be made where it would require relitigating a prior order of the Commission.
7. A protest may not rely on policy objections to an AL where the relief requested in the AL follows rules or directions established by statute or Commission order applicable to the utility. A protest shall provide citations or proofs where available to allow staff to properly consider the protest.

Cities and counties that need Board of Supervisors or Board of Commissioners approval to protest should inform DWA, within the 20 day protest period, so that a late filed protest can be entertained. The informing document should include an estimate of the date the proposed protest might be voted on.

REPLIES³

The utility shall reply to each protest and may reply to any response. Any reply must be received by DWA within five business days after the end of the protest period, and shall be served on the same day on each person who filed the protest or response to the AL.

SPECIAL CONDITIONS APPLICABLE TO ALL SERVICE AREAS

1. The fire protection service and connection shall be installed by the Utility's or under the Utility's direction. Cost of the entire fire protection installation shall be paid for by the applicant. Such payment shall not be subject to refund.
2. If the distribution main of adequate size to serve a private fire protection system in addition to all other normal service does not exist in the street or alley adjacent to the premises to be served, then a service main from the nearest existing main of adequate capacity will be installed by the utility at the cost of the applicant. Such cost shall not be subject of refund.
3. The installation housing the detector type check valve and meter and appurtenances there to shall be in a location mutually agreeable to the applicant and the utility. Normally, such installation shall be located on the premises of applicant, adjacent to the property line. The expense of maintaining the fire protection facilities on the applicant's premises (including the vault, meter, detector, type check valves, backflow device and appurtenances) shall be paid for by the applicant.
4. The utility will supply only such water at such pressure as may be available from time to time as a result of its normal operation of the system.
5. All bills are subject to the reimbursement fee set forth in Schedule No. UF.
6. Any unauthorized use of water other than fire protection purposes, charges shall be made therefore under Schedule No. 1 General Metered Service for the applicable district, at the regular established rate for general metered service, including applicable surcharges, and/or may be grounds for the Utility discontinuing the fire protection service without liability to the Utility.
7. All facilities paid for by the applicant, excluding the connection at the main and any service pipe located in a public right-of-way, shall be the sole property of the applicant. The Utility and its duly authorized agents shall have the right to ingress to and egress from the premises for all purposes relating to said facilities
8. The minimum diameter will be 1 inch, and maximum diameter will be the diameter of the main to which the service is connected.
9. Service hereunder if for private fire protection systems to which no connections for other than fire protection purposes are allowed and which are regularly inspected by the underwriters having jurisdiction. All facilities are to be installed according to the Utility's specifications and maintained to the Utility's satisfaction. The Utility may require the installation of a backflow prevention device and a standard protection against theft, leakage or waste of water
10. No structure shall be built over the fire protection service and the customer shall maintain and safeguard the area occupied by the service from traffic and other hazardous conditions. The customer will be responsible for any damage to the fire protection service facilities
11. Subject to the approval of the Utility, any change in the location or construction of fire protection service as may be requested by public authority or the customer will be made by the Utility following payment to the Utility of the entire cost of such change.
