At Illinois American Water, a team of over 500 employees in 13 operating districts work every day to provide quality water and wastewater services to approximately 1.3 million Illinois residents. Illinois American Water has five regional offices in the state: Alton, Chicago Metro, Peoria, Champaign County and Interurban (Belleville/Metro East).



## **INVESTING IN LOCAL INFRASTRUCTURE**

Illinois American Water invests approximately \$250 to \$275 million annually in water and wastewater improvements and infrastructure – from replacing and lining aging water and wastewater pipelines to upgrading water and wastewater treatment plants, storage tanks, wells, pumping stations, fire hydrants, meters, manholes and more.



#### **WATER QUALITY**

Illinois American Water monitors and tests water at multiple points throughout our process of drawing it from the source, treating it to meet ILEPA and U.S. EPA drinking water standards and distributing it through our pipeline systems. Illinois American Water has an exceptional track record in water quality. ### STATE REGULATORY OVERSIGHT

Illinois American Water is a regulated utility, so any changes to rates must be approved by the Illinois Commerce Commission. This process ensures customers are charged a fair price for the service received. While municipalities may subsidize the costs of providing service through taxes, fees and other sources, Illinois American Water rates reflect the cost of providing safe, reliable water and wastewater service.
